
### It is Chilling

"These are uncertain times," they say. How uncertain are these times, really? We know now who we are up against in this country — Putin, apparently. 
### A Christmas Wrap up

As Co-founder in 1983 and Executive Director of the Cultural Arts Coalition, she helped create the Annual 5th Ave Arts Festival, tours to HBCUs, Black History programs, Kwanzas, African American Men in the Public Schools, Girl Power, Environmental Youth Summit, the Environmental Ambassadors (a 30-year-old teen job training program) and presently seven Science Clubs for Elementary students in East Gainesville.

Her passion for the environment comes from her experience as a girl on her family's farm in Grandin; and she has developed a broad understanding of sustainability as encompassing social needs, education, healthcare, food and an equitable transition to clean energy. She shared some of her experiences starting out in segregated schools there, where she was surrounded by the supportive guidance of her teachers and extended family. Then she began being bussed to integrate Melrose schools, where she had to learn to face racism. However, on her bus, all the children were Black until the last few miles when white students were picked up and faced hostility from the kids already there. She remembers shopping at Williamson's after school. She moved to Gainesville to work and continue her education. Like so many children in her generation, the Boomer generation, the contradictions and violence of school integration fell on her shoulders.








# The Small and the Mighty: Twelve Unsung Americans Who Changed the Course of History from the Founding to the Civil Rights Movement


If you are feeling a longing for hope and dignity for our country in these recent chaotic times, read Sharon McMahon's recent book. This non-fiction, thoroughly researched book reads as if you were having a conversation with a friend. Ms. McMahon is a former history and government teacher who now holds the nickname "America's teacher" as the result of her popular podcast.

The twelve unsung Americans she writes of range from people we have heard of from Gouverneur Morris who wrote the preamble to the Constitution to Daniel Inouye, the long-time senator from Hawaii. She cites little known details from each of their lives that influenced them "to make a difference".

Lesser-known Americans such as Katherine Lee Bates who wrote "America the Beautiful" and Levi Straus of blue jeans fame are also included. Unique details of their lives are included as well. Bates was paid \$5 for her writing and Levi Straus did not use slave labor to make his products.

As a former history teacher, I was blown away by the unknowns she writes about that I had not heard of. For instance, the fifteen- year- old

girl who refused to give up her seat in Montgomery, Alabama well before Rosa Parks. Also, the Virginia teacher who started educating African-Americans after the Civil War leading to a proliferation of schools in the South secretly funded by one of the founders of Sears and Roebucks.

McMahon's writing style has been criticized by some as "getting off track" and disjointed. I, however, enjoyed her little side stories and off hand comments. She reads the audio version and anyone who enjoys her podcast, "Here Is Where It Gets Interesting", will likely enjoy the audio version.

#### The Terrorizing of Government Workers


The notices came as Delayed Resignation emails. Retire or Resign. These are the options offered to federal employees in February 2025. Also, in February came the notices of a Hiring Freeze and probable firing of probationary employees. Probationary employees are either new to federal service or to a different position than was previously held. Emails from Elon Musk flew to current employees, demanding information about what duties they performed the week before, with threats of resignation if they do not reply.

All of this was bombarded onto the federal workers in the space of one month, February, and were obviously designed to stress-out and panic employees. These tactics are specifically designed to destabilize and unnerve our federal workers, but not those cronies in the current administration, even though they're federal employees too.

When an employee resigns a job, they are not entitled to continue benefits after 30 days, receive unemployment benefits, nor any type of welfare assistance. They lose health insurance, life insurance and matching agency contributions to 401Ks.

I'm a retired federal worker — I know about working for the federal government. There are several other benefits too, but these are the main ones and why most of us (I know about) chose to work in the federal government in the first place. Job security, good benefits and belief in the good works of supporting our citizens. We enjoyed the structure and opportunities for career growth while also performing worthwhile duties.

We know every workforce has its deadbeats and they do need to be weeded out and held accountable. What we don't need is to throw out the baby with the bath water; it's just ridiculous.



Careful selection will remove those who are not performing their duties up to standards and work with those who are going above and beyond, to make improvements and support those who insist on working for good advancement/development for all qualified peoples.

Although, federal officials and union leaders and legal experts question the legality of the resignation offer, the administration is still pushing it forward. Several employees have already been affected. They claim those who accept the "delayed resignation" will continue to be paid through September. However, that particular bit of information is not included in the actual resignation form that you are expected to sign, only in the email. Right away, I see a problem with that!

What type of manipulations will it take for the administration to continue to pay employees on a monthly or bi-weekly schedule when they are designated as "resigned" in the many systems we use for processing employee data? Surely the pay systems will require major adjustments.







I'm a retired federal HR Specialist and if something is not clearly written and documented, then it didn't happen, and good luck trying to prove otherwise. We must remain consistent in our resolve to continue this fight for democracy. We must endeavor to be self-sufficient through these tragic challenges, inconsistences and government chaos. The fact that Musk has total access to our information to manipulate as he sees fit is very unnerving.

I recommend that all federal employees print-out and maintain a "hard-copy" of their personnel file and keep it safe. Print your complete E-OPF (Employee Official Personnel File), while you still have access to do so!!

If you are retired and do not have a copy of your completed retirement package and E-OPF, you can request it (in writing with identification proof) from The National Archives, if that is still an option now. The National Archives for administration records is non-partisan but is already being targeted by this administration. Apparently, the chief of the Archives was fired a couple weeks ago. Seems they want to block that access for us, too!!


